The Board of Directors of Pace, the Suburban Bus Division of the Regional Transportation Authority, met in public session on Wednesday, January 11, 2017, at 4:30 P.M. at Pace corporate headquarters, 550 West Algonquin Road, Arlington Heights, Illinois, pursuant to notice.

Acting Chairman Larson led assembly in the Pledge of Allegiance.

Acting Chairman Larson called the meeting to order at 4:30 P.M.

**SBD** #17-04 - Ordinance authorizing a change order to Contract No. 221661 with Johnson & Bell, Ltd., for Auto, General Liability, and General Litigation Services. This action increases the contract total from \$1,751,600.00 to \$2,751,600.00, an increase of \$1,000,000.00. (RFP 417124)

**SBD** #17-05 - Ordinance authorizing the award of a contract to First Transit, Inc., for West Cook County Paratransit, in an amount not to exceed \$54,282,015.91. (RFP 416714)

The motion passed with the following roll call vote: Directors Canning, Claar, Hastings, Larson, Marcucci, Nowaczyk, Schielke, Shepley, Soto, Stephens, Wells and Chairman Kwasneski all voted Aye. No Director voted Nay.

**SBD** #17-06 – Ordinance authorizing the Executive Director to take such action as he deems necessary, or appropriate, to implement and administer a contract with Metra for the buildout and leasing of space on the eighth floor of the Metra building, located at 547 W. Jackson Boulevard, Chicago, Illinois.

Director Shepley made a Motion to amend the language of the Ordinance changing the language to read as follows: "Authorizing the Executive Director to execute a contract with Metra for the Buildout and leasing of space on the eighth floor located at 547 W. Jackson Boulevard, Chicago, Illinois. The motion to amend was moved by Director Soto, and seconded by Director Canning. The motion was passed unanimously by the Board of Directors.

Acting Chairman Larson asked for a motion to adjourn into Closed Session for the purpose of discussing Closed Session minutes (2-C-21) and Pending Litigation (2-C-11). Director Nowaczyk moved, and Director Soto seconded the motion. The motion passed with a unanimous vote from the Board of Directors at 5:28 P.M.
