



St. Charles - Geneva Call-n-Ride Service Area

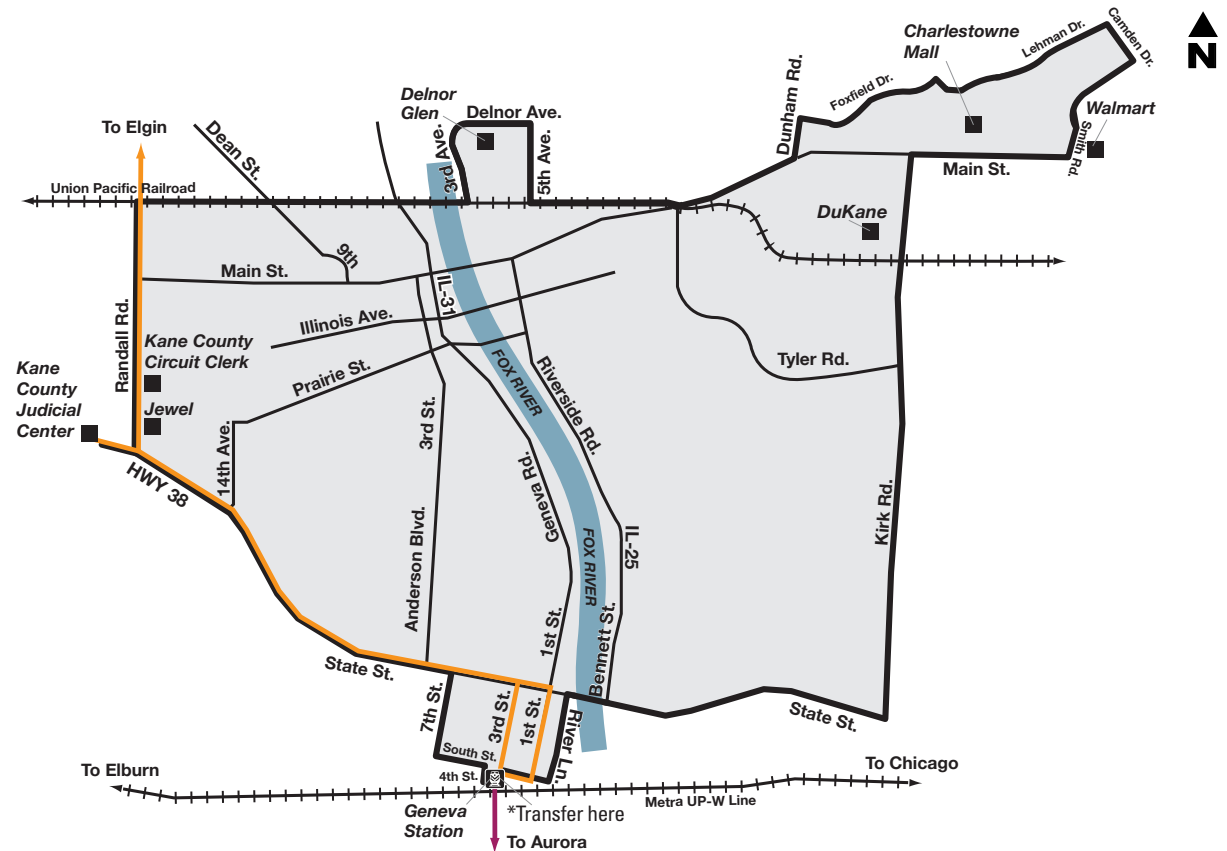
An affordable ride is right outside your front door.

For only \$2.00 per one way trip, the St. Charles - Geneva Call-n-Ride offers reservation-based, curb-to-curb, public transportation service for general public commuters travelling anywhere within the designated service area bounded by the Geneva Station, 4th St., South St., 7th St., State St./Highway 38, Randall Rd., Union Pacific railroad tracks, 3rd Ave., Delnor Ave., 5th Ave., Union Pacific Railroad tracks, Main St., Dunham Rd., Foxfield Dr., Lehman Dr., Camden Dr., Smith Rd., Main St., Kirk Rd., State St., River Ln., South St. and 3rd St. See map to the right.

Reserving a trip is easy. You can reserve your ride online at PaceBus.com/CnR. You can also call **630-379-2452** to reserve your trip at least one hour in advance and up to one day in advance (based on availability). Subscription trips (trips you regularly take at the same time and day without calling to reserve every trip) may be available. Ask your driver.

Trip reservations are not needed at scheduled stops. Passengers may simply board the bus at the location with the scheduled stop. See schedule on the back cover.

The St. Charles - Geneva Call-n-Ride is wheelchair accessible. Trips are scheduled on a first come, first served basis. Please be ready five minutes before your scheduled pick up time. Pace Call-n-Rides accept cash and Ventra®. Transfers to/from Pace fixed route buses are \$.30 when using a Ventra card. Reduced fares are available for eligible customers. The fare for customers who pay cash is \$2.25, and no discounted transfer is offered to cash payers. For more information, visit PaceBus.com.
